- 4. 90 days records of security incidents and response and 90 days periodic security systems alarm functionality checks (3.4.2, 3.4.9)
- 5. Secure pre-booking (3.4.10)
- 6. Technical User Manual (3.4.11)
- 7. Screening & vetting of personnel (3.5.1)
- 8. Return of all job-related sensitive information and/or equipment for terminated personnel and restriction of access to security systems or site records (3.5.2, 3.5.3)

- 9. Intrusion detection and gates in physical barrier (1.1.5, 1.1.8)
- 10. Measures in entry & exit points to prevent tailgating, sabotage, controls to ensure only 1 truck enters or depart each time (1.1.10, 1.1.11, 1.1.12)
- 11. Intercom at entry/exit points (1.3.3)
- 12. Mandatory physical guarding onsite (3.2.1)
